NOTICE OF VARIATION OF LICENCE NO. 6061

BACKGROUND

- A. WOLLONDILLY SHIRE COUNCIL (**licensee**) is the holder of Environment Protection Licence No. 6061 (**licence**) issued under the *Protection of the Environment Operations Act 1997 (Act)*. The licence authorises the carrying out of activities at ANTHONY ROAD, BARGO, NSW, 2574 (**premises**).
- B. On 23 January 2026, the Environment Protection Authority (**EPA**) received an application to vary the licence to extend the due dates in licence conditions E1-E5, which require landfill closure works at the premises including design works, final capping, installation of gas collection infrastructure and decommissioning of a sediment pond, among other works (**closure works**).
- C. On 11 February 2026, the EPA met with the licensee to discuss their extension request and the project management plan for the closure works (DOC26/37832-2). During the meeting the licensee explained the delays to closure works were caused by issues with procuring a principal contractor. The licensee also explained the expected completion dates for each key stage of the project.
- D. The EPA has reviewed the information provided and has varied the licence to extend the due dates listed in the licence.
- E. As part of the extension approval, the EPA is requiring quarterly progress reports for the entire duration of the project.
- F. Section 45 of the Act has been considered when varying this licence.
- G. On 13 February 2026, the EPA sent a draft version of the licence to the licensee for comments.
- H. On 13 February 2026, the licensee responded with approval to finalise the draft variation.

1. By this notice the EPA varies licence No. 6061. The attached licence document contains all variations that are made to the licence by this notice.
2. The following variations have been made to the licence:
 - Varied licence condition E1, extending the due date for submitting detailed design documentation from 31 January 2026 to 30 June 2027 and an updated closure plan from 31 March 2026 to 30 September 2027.
 - Varied licence condition E2, extending the due date for final capping and revegetation from 30 November 2026 to 31 December 2028.
 - Varied licence condition E3, extending the due date for construction of the cut off wall from 30 November 2026 to 31 December 2028.
 - Varied licence condition E4, extending the due date for the installation of an active landfill gas management system from 30 November 2026 to 31 December 2028 and to commence monitoring of subsurface gas from 30 May 2026 to 31 December 2028.
 - Varied licence condition E5, extending the due date for the decommissioning of Sediment Pond A from 30 November 2026 to 31 December 2028.
 - Varied licence condition E7, requiring quarterly written progress reports to be submitted to the EPA for the duration of the project (until 31 December 2028).

Information about this licence

Dictionary

A definition of terms used in the licence can be found in the dictionary at the end of this licence.

Responsibilities of licensee

Separate to the requirements of this licence, general obligations of licensees are set out in the Protection of the Environment Operations Act 1997 ("the Act") and the Regulations made under the Act. These include obligations to:

- ensure persons associated with you comply with this licence, as set out in section 64 of the Act;
- control the pollution of waters and the pollution of air (see for example sections 120 - 132 of the Act);
- report incidents causing or threatening material environmental harm to the environment, as set out in Part 5.7 of the Act.

Variation of licence conditions

The licence holder can apply to vary the conditions of this licence. An application form for this purpose is available from the EPA.

The EPA may also vary the conditions of the licence at any time by written notice without an application being made.

Where a licence has been granted in relation to development which was assessed under the Environmental Planning and Assessment Act 1979 in accordance with the procedures applying to integrated development, the EPA may not impose conditions which are inconsistent with the development consent conditions until the licence is first reviewed under Part 3.6 of the Act.

Duration of licence

This licence will remain in force until the licence is surrendered by the licence holder or until it is suspended or revoked by the EPA or the Minister. A licence may only be surrendered with the written approval of the EPA.

Licence review

The Act requires that the EPA review your licence at least every 5 years after the issue of the licence, as set out in Part 3.6 and Schedule 5 of the Act. You will receive advance notice of the licence review.

Fees and annual return to be sent to the EPA

For each licence fee period you must pay:

- an administrative fee; and
- a load-based fee (if applicable).

The EPA publication “A Guide to Licensing” contains information about how to calculate your licence fees. The licence requires that an Annual Return, comprising a Statement of Compliance and a summary of any monitoring required by the licence (including the recording of complaints), be submitted to the EPA. The Annual Return must be submitted within 60 days after the end of each reporting period. See condition R1 regarding the Annual Return reporting requirements.

Usually the licence fee period is the same as the reporting period.

Transfer of licence

The licence holder can apply to transfer the licence to another person. An application form for this purpose is available from the EPA.

Public register and access to monitoring data

Part 9.5 of the Act requires the EPA to keep a public register of details and decisions of the EPA in relation to, for example:

- licence applications;
- licence conditions and variations;
- statements of compliance;
- load based licensing information; and
- load reduction agreements.

Under s320 of the Act application can be made to the EPA for access to monitoring data which has been submitted to the EPA by licensees.

A3.2 The document titled "Wollondilly Shire Council April 1998 Bargo Non-Putrescible Waste Management Centre Landfill Environmental Management Plan" is not to be taken as part of the documentation in A3.1, other than those parts specifically referenced in this licence.

L1 Pollution of waters

L1.1 Except as may be expressly provided in any other condition of this licence, the licensee must comply with section 120 of the Protection of the Environment Operations Act 1997.

L2 Concentration limits

L2.1 For each monitoring/discharge point or utilisation area specified in the table/s below (by a point number), the concentration of a pollutant discharged at that point, or applied to that area, must not exceed the concentration limits specified for that pollutant in the table.

L2.2 Where a pH quality limit is specified in the table, the specified percentage of samples must be within the specified ranges.

L2.3 To avoid any doubt, this condition does not authorise the pollution of waters by any pollutant other than those specified in the table/s.

L3 Waste

L3.1 The licensee must not cause, permit or allow any waste to be received at the premises, except the wastes expressly referred to in the column titled "Waste" and meeting the definition, if any, in the column titled "Description" in the table below.

Any waste received at the premises must only be used for the activities referred to in relation to that waste in the column titled "Activity" in the table below.

Any waste received at the premises is subject to those limits or conditions, if any, referred to in relation to that waste contained in the column titled "Other Limits" in the table below.

This condition does not limit any other conditions in this licence.

L3.2 The total amount of waste received at the premises must not exceed 12,000 tonnes in any twelve month period.

L3.3 The licensee must not dispose of any tyre at the premises unless:

- The tyre has a diameter of 1.2 metres or more; and/or
- The tyre has been shredded or had its walls removed; and/or
- The tyre was delivered to the premises as part of a domestic load.

L3.4 For the purposes of this condition:

- Tyres are taken to be shredded only if the tyres are in pieces measuring no more than 250mm in any direction; and

b) Domestic load means a load containing no more than 5 tyres having a diameter of less than 1.2 metres.

L3.5 Tyres stockpiled on the premises must:

- a) be located in a clearly defined area away from the tipping face; and
- b) be managed to control vermin; and
- c) be managed to prevent any tyres from catching fire.

L4 Noise limits

L4.1 Noise from the premises must not exceed an LA10 (15 minute) noise emission criterion of 55 dB(A), except as expressly permitted by this licence.

L4.2 Noise from the premises is to be measured at any point within one metre of the nearest affected residence or other noise sensitive areas to determine compliance with Condition L4.1. 5dB(A) must be added if the noise is tonal or impulsive in character.

L5 Potentially offensive odour

L5.1 No condition of this licence identifies a potentially offensive odour for the purposes of section 129 of the Protection of the Environment Operations Act 1997.

Note: Section 129 of the Protection of the Environment Operations Act 1997, provides that the licensee must not cause or permit the emission of any offensive odour from the premises but provides a defence if the emission is identified in the relevant environment protection licence as a potentially offensive odour and the odour was emitted in accordance with the conditions of a licence directed at minimising odour.

4 Operating Conditions

O1 Activities must be carried out in a competent manner

O1.1 Licensed activities must be carried out in a competent manner.

This includes:

- a) the processing, handling, movement and storage of materials and substances used to carry out the activity; and
- b) the treatment, storage, processing, reprocessing, transport and disposal of waste generated by the activity.

O2 Maintenance of plant and equipment

O2.1 All plant and equipment installed at the premises or used in connection with the licensed activity:

- a) must be maintained in a proper and efficient condition; and
- b) must be operated in a proper and efficient manner.

O3 Dust

- O3.1 All operations and activities occurring at the premises must be carried out in a manner that will minimise the emission of dust from the premises.

O4 Emergency response

- O4.1 All activities and operations at the premises must be carried out in a manner that will prevent and minimise the risk of fires.

O5 Processes and management

- O5.1 The licensee must take all practicable steps to control entry to the premises.
- O5.2 Recycling facilities at the premises must be clearly marked and be available for access by the public.

O6 Waste management

- O6.1 There must be no incineration or burning of any waste at the premises.
- O6.2 The licensee must ensure that the achieved compaction rate of landfilled waste (excluding cover material) is stated in the annual report for the waste premises submitted to the EPA.
- O6.3 The licensee must ensure that the landfill cells are capped progressively and in accordance with condition O6.6 during operations and specifically at times when the level of waste reaches final heights as detailed in the LEMP.
- O6.4 Final capping must comprise five layers in the order of installation: a seal bearing surface, a gas drainage layer, a sealing layer, an infiltration layer and the revegetation layer as specified in Section 5.3.2 of the LEMP.
- O6.5 Cover material must be Virgin excavated natural materials.
- a) Daily cover
Cover material must be applied to a minimum depth of 15 centimetres over all exposed landfilled waste prior to ceasing operations at the end of each day.
 - b) Intermediate cover
Cover material must be applied to a depth of 30 centimetres over surfaces of the landfilled waste at the premises which are to be exposed for more than 90 days.
 - c) Cover material stockpile
At least two weeks cover material must be available at the premises under all weather conditions. This material may be won on site, or alternatively a cover stockpile must be maintained adjacent to the tip face.
- O6.6 Where wastes are received at the Premises for purposes of reuse, reprocessing, recovery, recycling or transfer to another premises, then such wastes are not required to be covered on a daily basis provided that:
- a) Such wastes are stored and managed so as not to cause or be likely to cause any off-site environmental effects; and
 - b) Such wastes are stored in a clearly defined area of the premises away from the tipping face.

- O6.7 The licensee must manage the disposal of waste at the premises in accordance with the progressive filling plan titled "Bargo WMC Management Plans - Progressive Filling Program dated May 2005 and prepared by GHD Pty Ltd.
- O6.8 Vehicles leaving the premises must not track materials to external surfaces.
- O6.9 The licensee must not exhume any landfilled waste unless approved in writing by the EPA.

O7 Other operating conditions

- O7.1 The landfill surface must be contoured to ensure stormwater is managed separately from leachate.
- O7.2 Sedimentation ponds A and B must be operated and maintained so as to collect and impound, without discharge to waters external to the premises, all surface water from the 90th percentile 5 day rainfall event.
- O7.3 The licensee must manage sedimentation ponds A and B in accordance with the report titled "Bargo WMC Management Plans – Stormwater Management Plan" dated May 2005 and prepared by GHD.

5 Monitoring and Recording Conditions

M1 Monitoring records

- M1.1 The results of any monitoring required to be conducted by this licence or a load calculation protocol must be recorded and retained as set out in this condition.
- M1.2 All records required to be kept by this licence must be:
- in a legible form, or in a form that can readily be reduced to a legible form;
 - kept for at least 4 years after the monitoring or event to which they relate took place; and
 - produced in a legible form to any authorised officer of the EPA who asks to see them.
- M1.3 The following records must be kept in respect of any samples required to be collected for the purposes of this licence:
- the date(s) on which the sample was taken;
 - the time(s) at which the sample was collected;
 - the point at which the sample was taken; and
 - the name of the person who collected the sample.

M2 Requirement to monitor concentration of pollutants discharged

- M2.1 For each monitoring/discharge point or utilisation area specified below (by a point number), the licensee must monitor (by sampling and obtaining results by analysis) the concentration of each pollutant specified in Column 1. M3 Testing methods - concentration limits

M3.1 Subject to any express provision to the contrary in this licence, monitoring for the concentration of a pollutant discharged to waters or applied to a utilisation area must be done in accordance with the Approved Methods Publication unless another method has been approved by the EPA in writing before any tests are conducted.

Note: The *Protection of the Environment Operations (Clean Air) Regulation 2022* requires testing for certain purposes to be conducted in accordance with test methods contained in the publication "Approved Methods for the Sampling and Analysis of Air Pollutants in NSW".

M3.2 Monitoring for the concentration of a pollutant emitted to the air required to be conducted by this licence must be done in accordance with:

- any methodology which is required by or under the Act to be used for the testing of the concentration of the pollutant; or
- if no such requirement is imposed by or under the Act, any methodology which a condition of this licence requires to be used for that testing; or
- if no such requirement is imposed by or under the Act or by a condition of this licence, any methodology approved in writing by the EPA for the purposes of that testing prior to the testing taking place.

M4 Recording of pollution complaints

- M4.1 The licensee must keep a legible record of all complaints made to the licensee or any employee or agent of the licensee in relation to pollution arising from any activity to which this licence applies.
- M4.2 The record must include details of the following:
- the date and time of the complaint;
 - the method by which the complaint was made;
 - any personal details of the complainant which were provided by the complainant or, if no such details were provided, a note to that effect;
 - the nature of the complaint;
 - the action taken by the licensee in relation to the complaint, including any follow-up contact with the complainant; and
 - if no action was taken by the licensee, the reasons why no action was taken.
- M4.3 The record of a complaint must be kept for at least 4 years after the complaint was made.
- M4.4 The record must be produced to any authorised officer of the EPA who asks to see them.

M5 Telephone complaints line

- M5.1 The licensee must operate during its operating hours a telephone complaints line for the purpose of receiving any complaints from members of the public in relation to activities conducted at the premises or by the vehicle or mobile plant, unless otherwise specified in the licence.
- M5.2 The licensee must notify the public of the complaints line telephone number and the fact that it is a complaints line so that the impacted community knows how to make a complaint.
- M5.3 The preceding two conditions do not apply until 3 months after: the date of the issue of this licence.

M6 Other monitoring and recording conditions

- M6.1 The licensee must record the following data for every fire at the premises:
- the time and date that the fire started;
 - the time and date that the fire was either burnt out or extinguished;
 - the location of the fire (eg. clean timber stockpile, putrescible garbage cell etc.);
 - prevailing weather conditions; and
 - observations made in regard to smoke direction and dispersion.

6 Reporting Conditions

R1 Annual return documents

- R1.1 The licensee must complete and supply to the EPA an Annual Return in the approved form comprising:
- a Statement of Compliance,

2. a Monitoring and Complaints Summary,
3. a Statement of Compliance - Licence Conditions,
4. a Statement of Compliance - Load based Fee,
5. a Statement of Compliance - Requirement to Prepare Pollution Incident Response Management Plan,
6. a Statement of Compliance - Requirement to Publish Pollution Monitoring Data; and
7. a Statement of Compliance - Environmental Management Systems and Practices.

At the end of each reporting period, the EPA will provide to the licensee notification that the Annual Return is due.

- R1.2 An Annual Return must be prepared in respect of each reporting period, except as provided below.
- R1.3 Where this licence is transferred from the licensee to a new licensee:
- a) the transferring licensee must prepare an Annual Return for the period commencing on the first day of the reporting period and ending on the date the application for the transfer of the licence to the new licensee is granted; and
 - b) the new licensee must prepare an Annual Return for the period commencing on the date the application for the transfer of the licence is granted and ending on the last day of the reporting period.
- R1.4 Where this licence is surrendered by the licensee or revoked by the EPA or Minister, the licensee must prepare an Annual Return in respect of the period commencing on the first day of the reporting period and ending on:
- a) in relation to the surrender of a licence - the date when notice in writing of approval of the surrender is given; or
 - b) in relation to the revocation of the licence - the date from which notice revoking the licence operates.
- R1.5 The Annual Return for the reporting period must be supplied to the EPA via eConnect *EPA* or by registered post not later than 60 days after the end of each reporting period or in the case of a transferring licence not later than 60 days after the date the transfer was granted (the 'due date').
- R1.6 The licensee must retain a copy of the Annual Return supplied to the EPA for a period of at least 4 years after the Annual Return was due to be supplied to the EPA.
- R1.7 Within the Annual Return, the Statements of Compliance must be certified and the Monitoring and Complaints Summary must be signed by:
- a) the licence holder; or
 - b) by a person approved in writing by the EPA to sign on behalf of the licence holder.
- Note: The term "reporting period" is defined in the dictionary at the end of this licence. Do not complete the Annual Return until after the end of the reporting period.
- Note: An application to transfer a licence must be made in the approved form for this purpose.
- R1.8 The Annual Return must be accompanied by / or include an Annual Report which must contain an assessment of environmental performance relevant to licence conditions including:
- a) tabulated results of all monitoring data required to be collected by this licence;
 - b) a graphical presentation of data from at least the last three years (if available) in order to show variability and / or trends. Any statistically significant variations or anomalies should be highlighted and explained;

- c) an analysis and interpretation of all monitoring data;
- d) an analysis of and response to any complaints received;
- e) identification of any deficiencies in environmental performance identified by the monitoring data, trends or incidents and of remedial action taken or proposed to be taken to address these deficiencies; and
- f) recommendations on improving the environmental performance of the facility.

R2 Notification of environmental harm

- R2.1 Notifications must be made by telephoning the Environment Line service on 131 555.
- R2.2 The licensee must provide written details of the notification to the EPA within 7 days of the date on which they became aware of the incident.

Note: The licensee or its employees must notify all relevant authorities of incidents causing or threatening material harm to the environment immediately after the person becomes aware of the incident in accordance with the requirements of Part 5.7 of the Act.

- R2.3 The EPA must be notified within 24 hours if the landfill gas monitoring of Point 9 required by condition M2.2 indicates a methane gas concentration of 500ppm (v/v) or greater.
- R2.4 The EPA must be notified within 24 hours if the landfill gas monitoring of Point 10 required by condition M2.2 indicates a methane gas concentration of 1.00% (v/v) or greater.

R3 Written report

- R3.1 Where an authorised officer of the EPA suspects on reasonable grounds that:
 - a) where this licence applies to premises, an event has occurred at the premises; or
 - b) where this licence applies to vehicles or mobile plant, an event has occurred in connection with the carrying out of the activities authorised by this licence, and the event has caused, is causing or is likely to cause material harm to the environment (whether the harm occurs on or off premises to which the licence applies), the authorised officer may request a written report of the event.
- R3.2 The licensee must make all reasonable inquiries in relation to the event and supply the report to the EPA within such time as may be specified in the request.
- R3.3 The request may require a report which includes any or all of the following information:
 - a) the cause, time and duration of the event;
 - b) the type, volume and concentration of every pollutant discharged as a result of the event;
 - c) the name, address and business hours telephone number of employees or agents of the licensee, or a specified class of them, who witnessed the event;
 - d) the name, address and business hours telephone number of every other person (of whom the licensee is aware) who witnessed the event, unless the licensee has been unable to obtain that information after making reasonable effort;
 - e) action taken by the licensee in relation to the event, including any follow-up contact with any complainants;
 - f) details of any measure taken or proposed to be taken to prevent or mitigate against a recurrence of such an event; and
 - g) any other relevant matters.

- R3.4 The EPA may make a written request for further details in relation to any of the above matters if it is not satisfied with the report provided by the licensee. The licensee must provide such further details to the EPA within the time specified in the request.

7 General Conditions

G1 Copy of licence kept at the premises or plant

- G1.1 A copy of this licence must be kept at the premises to which the licence applies.
- G1.2 The licence must be produced to any authorised officer of the EPA who asks to see it.
- G1.3 The licence must be available for inspection by any employee or agent of the licensee working at the premises.

8 Special Conditions

E1 Landfill Closure Works - Detailed Design

- E1.1 By **30 June 2027**, the licensee must submit detailed design documentation to the EPA for the following elements of its Landfill Closure Plan (LCP):

1. the final landform, including any necessary waste exhumation and reprofiling
2. the final capping system
3. the post closure landfill gas management system
4. the post closure leachate management system
5. the post closure surface water management system
6. the post closure surface water, groundwater and sub-surface gas monitoring systems

- E1.2 The detailed design documentation referred to in condition E1.1 must:

1. be prepared in general accordance with the minimum standards outlined in the Environmental Guidelines: Solid Waste Landfills, 2nd Edition (EPA, 2016); and
2. be prepared in general accordance with the commitments and design principles outlined in the document titled "Bargo Waste Management Centre - Landfill Closure Plan" prepared by GHD Pty Ltd and dated 4 November 2024 (EPA reference DOC24/958758); and
3. include waste settlement modelling and a slope stability assessment; and
4. consider the potential impacts of mine subsidence that could result from the longwall mining that is proposed to be carried out beneath the landfill.

- E1.3 By 30 September 2027, the Licensee must ensure that its Landfill Closure Plan is updated to reference the

detailed design documentation prepared in accordance with Condition E1.1.

E2 Final Capping and Revegetation

E2.1 By no later than 31 December 2028, the landfill must be capped and revegetated in accordance with the conditions specified in this licence and the minimum standards prescribed by the EPA's Environmental Guidelines: Solid Waste Landfills (2016).

E2.2 Final Capping Layers

The final landfill cap must consist of the following layers, from bottom to top:

- a) a seal bearing layer;
- b) a sealing layer
- c) an infiltration drainage layer
- d) a revegetation layer

E2.3 Seal Bearing Layer

The licensee must install a seal bearing layer in accordance with the following specification and requirements:

- a) the seal bearing layer must consist of a mechanically compacted layer of minimum 300mm depth;
- b) installation and materials must comply with the specifications for the seal bearing layer outlined in Section 7 of the document titled "Bargo Waste Management Centre - Preliminary Technical Specification" prepared by GHD Earth Scientists Pty Ltd dated 4 June 2024.

E2.4 Sealing Layer

The licensee must install a sealing layer over the seal bearing layer. The sealing layer must consist of a composite liner including a Geosynthetic Clay Liner (GCL), a linear low-density polyethylene (LLDPE) geomembrane and a geogrid reinforcement layer installed in accordance with the following specifications and requirements:

- a) installation and materials must meet the specifications outlined in the document titled "Bargo Waste Management Centre – Preliminary Technical Specification" prepared by GHD Earth Scientists Pty Ltd dated 4 June 2024; and
- b) construction of the sealing layer must not commence until the Installation Report for the seal bearing layer has been submitted to the EPA in accordance with condition E3.9

E2.5 Infiltration Drainage Layer

The licensee must install an infiltration drainage layer above the sealing layer to remove infiltrating water and drain it away from the landfill. The infiltration drainage layer must be comply with the following specification and requirements:

- a) Infiltration drainage layer must be at least 300mm thick, and
- b) consist of hard, strong, durable and clean gravel with a saturated hydraulic conductivity to water of greater

than 1×10^{-4} metres / second

c) have particle size, chemical reactivity and shape properties specified for gravel drainage aggregate in section 1.4 of the EPA Environmental Guidelines Solid Waste Landfills

E2.6 Revegetation Layer

The licensee must install a revegetation layer over the infiltration drainage layer. The revegetation later must comply with the following specifications and requirements:

a) the revegetation layer must be at least 100 centimetres thick and comprise clean soils and vegetation with root systems that will not penetrate into the lower layers of the cap.

b) soils used for construction of the revegetation layer must comply with the specification outlined in section 8 of the document titled "Bargo Waste Management Centre – Preliminary Technical Specification" prepared by GHD Earth Scientists Pty Ltd dated 4 June 2024.

E3 Construction of Cut off Wall

E3.1 By **31 December 2028**, the licensee must construct a cut off wall along the western side of the landfill to limit subsurface inflow to the waste mass and reduce leachate generation.

E3.2 The cut off wall layout and design shall be generally in accordance with that describe in section 10 of the document titled "*Bargo Waste Management Centre – Preliminary Technical Specification*" prepared by GHD Earth Scientists Pty Ltd dated 4 June 2024 and must be confirmed in the updated closure plan required by condition E1.3.

E4 Installation of active landfill gas collection system

E4.1 By **31 December 2028**, the licensee must install an active gas management system as described in section 5.3.3 of the document titled "Bargo Waste Management Centre – Landfill Closure Plan" prepared by GHD Pty Ltd and dated 4 November 2024.

E4.2 By **31 December 2028**, the licensee must install and commence monitoring of a network of subsurface landfill gas monitoring bores. The network of bores must be designed to ensure that subsurface gas monitoring is capable of detecting any lateral migration of gas from the landfill.

E5 Decommissioning of Sediment Pond A

E5.1 By **31 December 2028**, the licensee must decommission Sediment Dam A.

E6 Construction Quality Assurance

E6.1 The licensee must prepare and implement a Quality Assurance / Quality Control (QA/QC) Plan for the construction and installation of the landfill cap and gas management system. The QA/QC Plan must be

prepared by a suitably qualified and independent consultant.

The licensee must submit an Installation Report for each layer of the landfill cap and for the gas management system. This report must be prepared by a suitably qualified independent consultant and be submitted to the EPA within 1 month of the completion of each layer of the cap and within 1 month of completion of the gas management system. The report must be prepared in accordance with all relevant Australian Standards and include:

- i. A description of the works undertaken;
- ii. Works-as-executed drawings;
- iii. A discussion of the QA/QC activities undertaken;
- iv. Results of quality control testing undertaken (including material conformance testing, field seam testing for the GCL, etc.);
- v. Validation certificates for all VENM and material purported to meet the requirements of the relevant specifications referenced in other conditions of this licence;
- vi. Photographs documenting all major stages of installation;
- vii. A definitive statement from a suitably qualified engineer confirming that the works were constructed in accordance with the specifications and conditions of this licence.

E7 Quarterly Progress Report

E7.1 Every quarter, commencing on **31 March 2025**, the licensee must submit a written progress report to the EPA that includes an assessment of the progress of the landfill closure works and compliance with the Special Conditions listed in this licence. This report must include, but not be limited to;

- An overview of progress towards submission of the Detailed Design documentation and any relevant Development Approval (if applicable);
- An overview of progress towards completing the closure works outlined in the Landfill Closure Plan;
- An overview of any milestones that are behind schedule;
- An overview of actions to remedy any milestones that are behind schedule;
- A description of any anticipated or actual risks to the completion of the landfill closure works and the measures being implemented to mitigate those risks.

For clarity, the licensee must submit a written progress report to the EPA by:

E8 Other

- E8.1 All wastes and other materials received at or transported from the Premises must enter and exit the Premises over the weighbridge and be recorded in the weighbridge record system. These records must be made available to officers of the EPA upon request at any time.

E9 Updated methane sampling protocols

- E9.1 On 11 December 2025, the EPA varied the licence to change the frequency of landfill gas (methane) monitoring at the premises from monthly to quarterly. As part of the application for this variation, the licensee supplied a letter of recommendation prepared by the environmental consultant SMEC (SMEC letter) (EPA reference: DOC25/875692-3). The SMEC letter provided justification as to why the monitoring frequency should be reduced, and made recommendations that the licensee be required to comply with.

This condition requires the licensee to comply with all recommendations in the referenced SMEC letter. This includes:

- Quarterly methane monitoring during the interim care and maintenance period prior to final capping works commencing.
- Point 9 monitoring may be ceased during capping works, however Point 10 monitoring must continue and Point 10 monitoring must include all buildings within 250m of the deposited waste, whether existing or newly erected.
- Any future methane detections over 500ppm must be demarcated by bright coloured flags and all relevant stakeholders (Council, NSW EPA, contractors and any other stakeholders) must be notified immediately. The licensee must restrict movement of persons, plant and machinery through such areas, except as required for operation/cover repairs.
- The licensee must provide inductions to any person that attends the premises, and these inductions must include a briefing on the methane risk, the supply of monitoring results and mitigation measures required.
- While capping works are occurring, alternate methane detection must be in place for the safety of site staff and contractors. This may include personal methane monitors, or other measures as agreed by the licensee and contractor(s) to meet Work, Health and Safety (WHS) requirements as per management plans.
- Any ground penetration works and/or 'hot works' activities at the premises require activity-specific risk assessments and treatment controls to identify and manage risk of introducing potential ignition sources.
- While contractors may be engaged to conduct risk assessments, implement mitigation measures and complete construction works, the ultimate legislative responsibility for the premises remains with the licensee, and any breach or non-compliance must be reported to the NSW EPA in accordance with the licence.
