APPLICATION FOR CLASSIFICATION OF LAND AS FARM LAND FOR RATING PURPOSES

For land to be categorised as Farmland for rating purposes it must satisfy the criteria as set out in Section 515 of the Local Government Act 1993.

“Farmland” means a parcel of rateable land which is valued as one assessment and the dominant use is for farming which:

- (a) has a significant and substantial commercial purpose of character; and
- (b) is engaged for the purpose of profit on a continuous or repetitive basis (whether or not a profit is actually made).

“Farming” means the business or industry of grazing, animal feedlots, dairying, pig-farming, poultry farming, viticulture, orcharding, bee-keeping, horticulture, vegetable growing, the growing of crops of any kind, forestry, or aquaculture within the meaning of the Fisheries Management Act 1994, or any combination of those businesses or industries.

To assist Council in evaluating your eligibility to receive the benefits of farm land rating it will be necessary for you to complete the following questions. This questionnaire has been structured to help you provide Council with the information required for determining eligibility for Farmland rating. Your assistance with providing as much detail as possible would be appreciated.

If you have two or more adjoining assessments farmed as one holding, it is permissible to complete just one application form, provided that all of the assessment numbers are indicated. If properties do not adjoin, a separate application must be completed for each assessment.

Incomplete application forms will be returned to the applicant. It should be noted that all information contained in the application will be dealt with in the strictest of confidence.

Application Procedure

Council has 30 days to act on receipt of any new application. If an inspection is required, arrangements will be made via telephone to meet and review the details. If approved, Council will notify you in writing and the appropriate adjustments made to your rate account.

Notification will be sent if the application is declined stating the reason why. If you are not in agreement with Council's decision, a written request for a review can be made stating the reasons why. The application will be reviewed again and the property will be inspected.

If you are not satisfied with Council's review of the categorisation you may appeal to the Land and Environment Court of NSW within 30 days. Your attention is brought to section 525 and 526 of the Local Government Act 1993.
